8.1 Several of the states in the U.S. are following MTO guidelines for installing gravity pipe. There has been a 35% drop in prices since the guidelines were implemented.

8.2 The Drainage Act Proceedings course for staff is in March 2012.

8.3 There are many new technologies. MTO x-ray culverts to decide whether the culvert needs to be replaced, repaired or a new liner is needed. There is a polypropylene pipe product out which has a stiffness greater than HDPE pipe. It is ASTM and CSA approved.

8.4 IDF curves are on the MTO website.

8.5 The pipe inspection process is also now in place.
